5. Duties of the Treasurer.

The treasurer shall cause to occur the following:

- A. Maintenance of full and accurate financial records of the chapter including:
 - Assets, liabilities and fund balances
 - ii. Revenue and operating expenses
 - iii. All other financial records and documents deemed necessary by the Board
- B. Disbursement to National Headquarters the portion of membership dues required, according to the current dues structure of the American Guild of Organists as approved by National Council
- C. Disbursement of all other funds of the Chapter, in accordance with the authority granted by the Board, taking proper vouchers to correspond to the disbursements
- D. Preparation and submission of such reports or statements of the Chapter's finances and accounts as may be requested by the Board.
- E. Preparation and submission of Tax Returns and non-profit status reports

The treasurer shall also:

- A. Deposit all monies and credits in the name and to the credit of the Chapter in such accounts and depositories as may be designated by the Board
- B. Sign and/or countersign such instruments requiring his/her signature
- C. Serve as a member of the Investment Committee
- D. Assist the Board in preparing an annual budget
- E. Perform such other duties incidental to the execution of this office that may be required by the Board.

Note: the first section of duties are those that could be performed by a bookkeeping service with treasurer oversight. The second section of duties are those specific to the office that could not be done by an outside service.
