

Dean's Column

New Board Members

As you will see in this issue of *Pipenotes*, we have a new set of Board members. The class of 2017 – Jennifer Anderson, Pam Carlson, and Jon Kietzer – end their terms, and the class of 2020 – Tom Ferry, Diana Lee Lucker, and Chris Stroh – begin theirs. Like the rest of the Board, the class of 2017 has served us very well. Let me express my personal thanks to them and to the rest of the Board with whom it is a joy to work. And a hearty welcome and congratulations to the new Board members with thanks for their willingness to serve.



Since the election, Nancy Lancaster in the class of 2019 has

found it necessary to resign. I thanked her for her service and nominated Kyle Black to fill her position. The Board approved the nomination. Kyle has agreed to serve, for which I thanked him.

Federal Trade Commission Update

One of the continuing items of business this year will be the Federal Trade Commission's ruling that we may no longer have in our Code of Conduct the rule that members shall not seek a position held by someone else or apply for a position unless it is officially declared vacant, and that we may no longer publish salary guidelines. Let me try to indicate where these matters stand and offer some further perspective.

At some point soon, the ruling will become official. As I understand it, we will then have six months to comply. You will note that our former Code of Conduct has already been removed from our website, and the codes of ethics and professional standards (see below for some comments about them) are there already.

I have talked to a number of you, received communications from some of you, and had several contacts with James Thomashower about this. The Board has discussed it. From what I can tell, the National Council has pressed the Federal Trade Commission with the same questions we have raised, with as much vigor as we have expressed.

I think this is a push-comes-to-shove moment of state/church relationships. The Guild is not the church, but it was founded by church organists over a century ago, still serves that population, has chaplains, deals again and again with the Psalms where the praise of God and care for the other are relentlessly linked, and operates with that code in its fiber. When push-comes-to-shove, the state invariably looks to its own interests and by extension those of individuals in it. When push-comes-to-shove, the church invariably – at least when it has not collapsed into the state – looks to the interests of the other. That encompasses the self, but does not magnify the self at the expense of the other, as in "Love your

neighbor as yourself." The church and church-related entities have to figure out how to live as responsible citizens while still caring constructively – though paradoxically subversively – for the other, the neighbor (which includes the state and other states).

I think the Code of Professional Standards and the Code of Ethics approved by the AGO National Council on January 17, 2017 (on our home page and at the national website under Guild Documents) call us to the same ethical standards of conduct as before. We can embrace them. The salary guidelines are more perplexing because omitting them can be understood to mean that we cannot help churches who ask us about how to be fair financially, which is what our guidelines have been about and what churches want and need to know. The FTC apparently thinks that we, as James Thomashower told me, "have our thumbs on the scale." As we all know, we have nothing that even resembles that kind of control or power.

So, what to do? We can recommend that churches consult church music societies, denominational adjudicatories, school guidelines, and churches we know where there are fair salaries. In short, we can still care about the other, though we will have to do it a bit more creatively than before, without making specific salary recommendations ourselves. AGO Boards and Guild members are a creative bunch. We can figure this out.


Pipedreams Scholarship Winner

MPR

Classical Minnesota Public Radio encourages you to enter your classical music performance events in the MPR online calendar.

On the top bar of the general MPR web page, click on "Events," then "Events Calendar," then "Classical Music." However, if you find yourself on the Classical MPR main page, click on "More," then "Events," then "Classical Music."

In either case, once on the page that lists Classical Music Events, if you wish to add your own upcoming activity, under the headline for "Calendar Events Home" at the top of the page you should find an additional prompt for "Submit Event." Fill in all appropriate boxes (and check to see if your venue is already logged into the system, which might save you some time).

Note that this MPR Calendar information will reach a different audience than that submitted to Barone for posting on the TCAGO/*Pipedreams* calendar pages. Both are free, the one a selfservice feature and a separate vehicle by which you can let people (including the Classical MPR program hosts) know about your classical music concerts.

By all means, continue to send information directly to Michael Barone too!!

We also encourage you to regularly request organ selections on the "Friday Favorites" show with Steven Staruch. Encourage and promote the inclusion of more organ music in MPR's programming!
